

**Kurth Landrum Golf Course**  
**(Hereafter referred to as the Golf Course)**

**Facility Usage Policy**

**Date Effective: July 1, 2009**

Reservations for using the Golf Course may be made by calling 863-1333 or by dropping by the Golf Pro Shop. Tee time reservations are not taken for weekday play. Reservations may be made for weekend and holiday tee-times up to two days ahead of the desired reservation day. Tee times are subject to availability.

Groups wishing to reserve the golf facilities should contact Larry Connell at 863-1282.

**Hours of Operation**

From sun up to one hour before sunset year round. The Golf Course will be closed on Christmas Day.

Closing hours are subject to change without notice due to weather conditions.

**Scheduling Priorities**

Priorities for golf course use are as follows:

1. Southwestern golf classes
2. Official Southwestern golf team practice and tournaments
3. Intramural events
4. Other tournaments and events as deemed necessary.
5. University students, faculty and staff groups have priority over external constituent requests.

The University reserves the right to make judgments concerning facility usage and cancel events that are deemed dangerous and/or are not in compliance with regulations.

**Regulations for Use**

1. Use of the Golf Course is free for persons holding a valid Southwestern ID card. Presentation of the ID card is required for free use. (Fees will be assessed for rental of golf equipment and carts.)
2. The Golf Course is open for play to the general public for a small fee. The fees are displayed in the Pro Shop.
3. Children/Youth under the age of 12 must be accompanied by an adult to play.
4. The consumption, possession, or distribution of alcoholic beverages or any controlled substance is not permitted on the golf premises at any time.
5. Smoking or the use of other tobacco products is strictly prohibited within the Howry Center including the restrooms and Golf Pro Shop.
6. Bicycles, roller blades/skates and skateboards are not permitted on the golf course.

7. Proper attire is required for golfers. Shirts are required. Tank tops are not permitted for golfers over the age of 13. Golf shoes or soft sole shoes are required for the practice area and golf course.
8. All property found on the Golf Course or practice area should be turned in at the Golf Pro Shop desk.
9. Every golfer must have his/her own golf clubs and bag. Golf clubs are available for rent in the Golf Pro Shop. A valid Southwestern ID card or other valid ID will be required for deposit.
10. Golfers will be held financially responsible for the repair of damages resulting from improper use of the Golf Course, practice area, golf carts, equipment and Golf Pro Shop.
11. Golf carts are available for rent on a first-come, first-served basis. Rental fees are required prior to play and only persons who are 18 years of age and hold a valid driver's license are permitted to drive the cart.
12. Willful destruction or abuse of University property can result in expulsion from the golf premises and/or other University disciplinary action in addition to the assessment of fees for damages mentioned above.
13. Responsible action and behavior are expected. Individuals who engage in unacceptable behavior, abusive language or destructive action may have their access revoked or modified and/or subject to University action.
14. Southwestern, at its sole discretion, may restrict the use of the golf premises.

#### **Indemnification/Insurance**

External constituents wishing to rent the golf premises must provide a **Certificate of Insurance**. All aspects of this requirement are explained in the University's **Agreement for Use of Facilities**.

**Southwestern University is not responsible for injuries sustained or property lost/damaged while persons participate in its facilities.**

Exceptions to this policy must be approved by the Vice President for Fiscal Affairs.
